Malton Game & Seafood Fest 2016 – Trading Terms and Conditions

General

- 1.1 Stalls/pitches are non-transferable.
- 1.2 We reserve the right to amend the festival site plan at any time prior to the event date.
- 1.3 The Festival Organiser's decisions are final with regard to the festival formation and layout.
- 1.4 **Traders turning up on the day who have not prepaid will not be permitted to stand at the festival.**
- 1.5 The event is officially open for trading between: 9am to 4pm. Traders are required to stay for the full duration of the event and may only begin packing up after closing time.
- 1.6 Traders selling illegal, counterfeit or inappropriate goods will be removed from site and the relevant authorities informed.
- 1.7 Smoking is prohibited on site.
- 1.8 Refunds will not be given.
- 1.9 Traders who do not turn up to an event they have booked are not entitled to refunds and may jeopardise their applications to trade at future events.
- 1.10 The Organisers reserve the right to cancel this agreement at any time by giving notice in writing to the Trader at the address given on the application form whenever they are of the opinion that the continuance of the hiring would not be in the interests of the good and safe management of the site. This may be due factors such as adverse weather or any other circumstances beyond the organisers' control.
- 1.11 Traders must provide skirts for their stalls and stalls must be kept tidy at all times.
- 1.12 All Traders must remove rubbish and recycling from their site at the end of each day. You must make arrangements to deal with trade waste responsibly and are not permitted to use the public waste bins. Failure to comply with this condition will result in a £100 charge to the trader.
- 1.13 Traders must only sell what is stated on their application form.
- 1.14 NO GENERATORS are allowed.

Public Liability Insurance

- 2.1 Traders are responsible for the insurance of their own property and must have current Public Liability Insurance to the minimum value of £2 million at the time of the event.
- 2.2 Traders must submit photocopies of their insurance cover with the application form and have originals with them for inspection at the time of the event.
- 2.3 Traders or agents shall not hold the Organisers and/or Malton Amenity CIC responsible for any loss, damage, theft or destruction of any exhibit, goods, property or equipment.

Health and Safety

- 3.1 All stalls must meet Health & Safety Standards in line with the Health & Safety at Work Act 1974. Health and Safety officials will inspect the site during the event.
- 3.2 Stalls may be inspected by Environmental Health, Trading Standards Officers or any other professional body.
- 3.3 Traders who use powered appliances must supply the relevant safety certificates as well as fire extinguishers and adequate barriers around the powered equipment.
- 3.4 Traders selling food must provide food hygiene and safety certificates in advance of the event, as well as make them available for inspection on the day.
- 3.5 Stallholders using gas cylinders are expected to provide suitable storage facilities. All cylinders must be installed prior to the opening of the event and must not be transported during the event.
- 3.6 All electrical equipment must be PAT tested with a current sticker/certificate with the equipment.
